



EXECUTIVE ORDER NO. 153,
Series of 2023

**AN ORDER RECONSTITUTING THE PANABO CITY
PEOPLE'S LAW ENFORCEMENT BOARD (PLEB)**

WHEREAS, the People's Law Enforcement Board (PLEB) was created under Republic Act No. 6975 entitled "*An Act Establishing the Philippine National Police under Reorganized Department of the Interior and Local Government*" as amended by Republic Act No. 8551, otherwise known as "*Philippine National Police Reform and Reorganization Act of 1998*" to have jurisdiction to hear and decide citizen's complaints or cases filed before it against erring officers and members of the PNP;

WHEREAS, the aforesaid laws, mandates the establishment in every city or municipality of one (1) People's Law Enforcement Board (PLEB) for every five hundred (500) city or municipal personnel;

WHEREAS, Section 3, Rule 11 of Memorandum Circular No. 2016-002 of the Department of the Interior and Local Government (DILG) and National Police Commission, provides for the composition of the PLEB as recommended/chosen by the City Peace and Order Council (CPOC), the Association of Barangay Captains (ABC) and the Sangguniang Panlungsod (SP);

WHEREAS, DILG MC No. 2017-154 dated November 16, 2017 issued the Operational Guidelines on the Implementation of the People's Law Enforcement Boards Program;

WHEREAS, the SP, ABC and CPOC designated its members/representatives in the PLEB;

WHEREAS, Section 445 (b)(2)(iii) of the Local Government Code of 1991 grants the City Mayor the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, JOSE E. RELAMPAGOS, City Mayor, by virtue of the powers vested in me by law, do hereby reconstitute the People's Law Enforcement Board of Panabo City and further order the following:

SECTION 1. COMPOSITION. The composition of the members of the PLEB shall be as follows:

The members shall elect from among themselves the Chairperson of the Board.



SECTION 2. POWERS AND FUNCTIONS. The PLEB empowers the people against abusive and erring policemen. It has the power to hear and adjudicate all citizen's complaints formally filed with, or referred to it, against any uniformed members of the PNP, and. If warranted, impose the corresponding penalty.

The functions and roles of the PLEB are provided under a) Republic Act No. 6975, otherwise known as the Department of the Interior and Local Government Act of 1990, b) Memorandum Circular No. 91-002 of the National Police Commission, c) Republic Act No. 8551, otherwise known as the Philippine National Police Reform and Reorganization Act of 1998, d) Department of Interior and Local Government (DILG) Memorandum Circular No. 2002-010 or the *"Revised Rules of Procedure in the Hearing and Adjudication of Citizens Complaints Against Uniformed Members of the Philippine National Police before the PLEB"*, and e) Other applicable laws, rules, regulations and issuances.


SECTION 3. SECRETARIAT. Mr. **IAN JAY CASTAÑOS** from the Office of the City Mayor is hereby designated as PLEB Secretariat. The secretariat shall provide administrative support such as keeping the minutes, drafting of official correspondences, logistics affairs and other relevant tasks as may be assigned by the Board.

SECTION 4. TERM OF OFFICE. The term of office of the members of the PLEB shall be for a period of three (3) years from the assumption of office unless sooner removed for cause or some other valid grounds and shall hold office until his/her successor shall have been chosen and qualified.

SECTION 5. TECHNICAL ASSISTANCE. The DILG Panabo City shall provide technical and administrative assistance to the PLEB and its Secretariat.

SECTION 6. EFFECTIVITY. This order shall take effect immediately upon signing hereof.
