EXECUTIVE ORDER NO. 159 **SERIES OF 2023**

AN ORDER CREATING THE LOCAL PROJECT MANAGEMENT TEAM (LPMT) FOR THE FORMULATION OF THE COMPREHENSIVE LOCAL JUVENILE INTERVENTION PROGRAM (CLJIP) IN THE CITY OF PANABO

WHEREAS, the state recognizes the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty and exploitation, and other conditions prejudicial to their development;

WHEREAS, in accordance with Rule 24, a, b, c of the Revised Implementing Rules and Regulations (RIRR) of RA 9344 as amended by RA 10630, all Local Government Units (LGUs) through the Local Social Welfare and Development Office and Local Planning and Development Office shall develop their 3-5 year Comprehensive Local Juvenile Intervention Program based on the assessed local situation of their children-at-risk and children-in-conflict with the law supported by the Local Council for the Protection of Children (LCPC) on its adoption, implementation, monitoring and evaluation and it shall be implemented and be sourced from the 1% Internal Revenue Allotment;

WHEREAS, Rule 24.e of the RIRR of RA 9344 as amended, mandated the Department of Interior and Local Government (DILG) to issue the necessary guidelines for LGUs in the development, budget allocation, implementation, monitoring and evaluation of their CLJIP;

WHEREAS, the Guidelines for Local Government Units on the Development of the Comprehensive Local Juvenile Intervention Program (CLJIP) was formulated by the Department of Interior and Local Government (DILG) in partnership with the Juvenile Justice and Welfare Council through the issued DILG Memorandum Circular No. 2016-68;

WHEREAS, the crafting of CLJIP shall be based on the Comprehensive National Intervention Program (CNJIP) and it shall be formulated by LGUs through an organized Local Intervention Program Committee (LIPC) in coordination with all sectors concerned in accordance with Rule 18 of the Revised Implementing Rules and Regulations of RA 9344 as amended by RA 10630;

WHEREAS, the CLJIP shall be integrated in the Local Development Plan of the City;

WHEREAS, there is a need to create the Local Project Management Team (LPMT) from the LCPC who shall formulate the CLJIP as mandated under item IV, A (2) of the Guidelines for LGUs on the Development of the CLJIP;

NOW THEREFORE, I JOSE E, RELAMPAGOS, City Mayor of Panabo, Davao del Norte by virtue of the powers vested in me by law, do hereby order and direct the following:

SECTION 1. CREATION. The Local Project Management Team (LPMT) for the formulation of the Comprehensive Local Juvenile Intervention Program (CLJIP) of the City of Panabo and shall be composed by the following:

SECTION 2. FUNCTIONS. The LPMT of the City of Panabo shall be guided by Rule 24.a of the RIRR of RA 9344, as amended and shall perform the following functions:

- 1. Formulate the Comprehensive Local Juvenile Intervention Program ("Local Intervention Program") that shall cover a period of at least three (3) years consistent with the National Intervention Program formulated and designed by the JJWC.
- 2. Spearhead the efforts of the City in attaining the objectives of the CLIIP:
- 3. Lead and direct the conduct of social preparation activities (data gathering, planning process, and establishment of the Juvenile Information and Referral System in their respective LGUs;
- 4. Initiate and refine program planning, design and implementation;
- 5. Plan and oversee local monitoring and evaluation scheme with the technical assistance and supervision of the National TWG on Capacity-Building and submit annual reports to the DILG Central Office through its Regional Office;
- 6. Coordinate and lead the continuing capacity-building of the direct service providers;
- 7. Ensure that inputs from BCPCs are incorporated in their plans and that monitoring of the project, plans and activities are undertaken jointly;
- 8. Coordinate with the LCPC, all sectors concerned, particularly the child-focused institutions, NGOs, people's organizations, educational institutions and government departments involved in delinquency prevention and participate in the planning process and implementation of the Local Intervention Programs.
- 9. Ensure that the programs dealing with children shall be deemed part of the LCPC program.
- 10. Do an in-depth analysis of the problem and inventories of programs, services, facilities and resources available
- 11. Coordinate intervention and prevention efforts between governmental and non-governmental organizations.
- 12. Determine methods for effectively reducing the opportunity for children to commit offenses
- 13. Review and assess annually the implementation of the CLJIP in coordination with the LCPC.
- 14. Conduct consultation meetings and workshops as necessary in the formulation of the City's Juvenile Intervention Plan;

- 15. Draft, Review and/or endorse to the Sangguniang Panlungsod the Model Ordinance to implement the intervention and Diversion program pursuant to RA 9344 (Juvenile Justice and Welfare Act of 2006) as issued under the DILG issued Memorandum Circular No. 2009-124 dated September 1, 2009; and
- 16. Perform such other functions and related works as may be necessary in furtherance of this Order.

SECTION 3. SECRETARIAT. The City Social Welfare and Development Office is hereby designated as Secretariat of the LPMT and shall document the proceedings, prepare communications, and provide such other assistance as may be required by the team.

SECTION 4. OPERATIONAL EXPENSES AND FUNDING. There shall be an annual budget amount necessary to implement the juvenile intervention programs as provided in Section 18 of the Republic Act 9344, subject to the usual government accounting and auditing rules and regulations.

SECTION 5. EFFECTIVITY. This order shall take effect immediately upon signing hereof.
