## EXECUTIVE ORDER NO. 18 Series of 2024

## AN ORDER AMENDING THE COMPOSITION OF THE EXECUTIVE COMMITTEE FOR THE PANABO CITY YOUTH FESTIVAL

WHEREAS, Article 2 Section 13 of the 1987 Constitution states that "the State recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs";

**WHEREAS**, Republic Act No. 8044 otherwise known as the Youth in Nation-Building Act creates the structure to implement a comprehensive and coordinated program for the youth and gives recognition to the youth's responsibility in fulfilling their vital role in nation-building;

**WHEREAS**, Section 30 of Republic Act No. 10742 or the Sangguniang Kabataan Reform Act of 2015, mandates the observance of *Linggo ng Kabataan* in every barangay, municipality, city and province on the week where the 12<sup>th</sup> of August falls;

**WHEREAS**, Chapter VI, Section 33 (a) of RA 10742, mandates the conduct of an annual activity for the youth to be known as the *Linggo ng Kabataan* every 12<sup>th</sup> of August, coinciding with the observance of the International Youth Day;

**WHEREAS**, the City Government of Panabo through the 9<sup>th</sup> City Council, promulgated City Ordinance No. 3-2023 entitled "Declaring Every 2<sup>nd</sup> Week of August of Each Year as the Panabo City Youth Festival also known as the Linggo ng Kabataan Celebration and Providing Funds Thereof";

WHEREAS, Section 7 of City Ordinance No. 03-2023, mandated the creation of an Executive Committee to oversee and direct the conduct of all programs and activities of the Panabo City Youth Festival;

**WHEREAS**, in view of the recently concluded 2023 Barangay and Sangguniang Kabataan Elections, there is a need to amend the composition of the Panabo Youth Festival Executive Committee as created under Executive Order No. 228, Series of 2023;

**NOW, THEREFORE, I, JOSE E. RELAMPAGOS,** by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. COMPOSITION.** The Panabo City Youth Festival Executive Committee as created under City Ordinance No. 03-2023 shall be composed of the following:

**SECTION 2. FUNCTIONS.** Panabo City Youth Festival Executive Committee shall perform the following functions:

- Supervise the conduct of all programs and activities of the Panabo City Youth Festival as identified and approved by the Local Youth Development Council and Sangguniang Kabataan City Federation;
- b. Call upon any government offices and department including barangay local government unit, for any assistance; and
- c. Perform such other functions necessary to accomplish the foregoing.

**SECTION 3. MEETINGS AND QUORUM.** The Executive Committee shall meet in the month of June or as necessary to discharge its duties and responsibilities.

The presence of at least a majority of its members and/or the authorized representatives shall constitute a quorum and the affirmative vote of the majority of its members and/or the authorized representatives present in a meeting shall be necessary for the committee to exercise its powers and functions.

**SECTION 4. OPERATIONAL EXPENSES AND FUNDING.** The budget for the Youth Festival shall be sourced out from the City Mayor's Office-Local Youth Development Office, all subject to the usual government accounting and auditing rules and regulations.

SECTION 5. EFFECTIVITY. This order shall take effect immediately after signing hereof.
