#### AN ORDER CREATING THE LOCAL SELECTION COMMITTEE FOR THE SELECTION OF CIVIL SOCIETY ORGANIZATION REPRESENTATIVES AND PRIVATE SECTOR REPRESENTATIVE TO THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL

**WHEREAS**, the Philippine Constitution provides that the state shall facilitate the establishment of adequate consultation mechanisms for genuine people's participation in local governance;

**WHEREAS**, the Local Government Code of 1991 provides that local government units shall promote the establishment and operation of People's (POs) and Non-Governmental Organizations (NGOs)/ Civil Society Organizations (CSOs) to become active partners in the pursuit of local autonomy;

**WHEREAS**, the Republic Act 10121 states to engage the participation of civil society organizations (CSOs), the private sector, and volunteers in the government's disaster risk reduction programs towards complementation of resources and effective delivery of services to the citizenry;

**WHEREAS**, the National Disaster Risk Reduction and Management Council (NDRRMC) issued Memorandum Circular No. 07, S. 2022, prescribes the Guidelines for the Selection of Representatives from Civil Society Organizations and the Private Sector to the National Regional and Local Disaster Risk Reduction and Management Councils (DRRMCs);

**WHEREAS**, the City of Panabo recognizes the need to establish the Local Selection Committee for the determination of eligible Civil Society Organizations and the Private Sector as members of the City Disaster Risk Reduction and Management Council (CDRRMC). Also, ensure a transparent, efficient and effective accreditation process;

**WHEREAS**, 10.3 of the NDRRMC Memorandum Circular No. 07, S. 2022 designated the composition of the Selection Committee at the local level;

**NOW THEREFORE, I, JOSE E. RELAMPAGOS, Mayor of Panabo City, Davao Del Norte,** by virtue of the powers vested in me by law, do hereby order:

**SECTION 1. CREATION AND COMPOSITION.** There is hereby created a Local Selection Committee for the accreditation of Civil Society organizations and Private Sectors in the CDRRMC which shall be composed of the following:

**SECTION 2. FUNCTIONS.** The Committee shall have the following functions:

- a. Review and evaluate the eligibility and the capability of Civil Society Organizations and the Private Sector applying for accreditation based on the set criteria;
- b. Select the CSO representatives for the four (4) categories and one (1) private sector representative;
- c. Give preference and priority to NGOs/CSOs with undeniable record of engagement and competence in DRRM and/or Climate Change initiatives as well as networks;
- d. Submit the result of the selected representatives to the Chairperson of the CDRRMC for his approval in the four categories of CSOs and one private sector representation in the CDRRMC;
- e. Perform such other functions stated under the issued NDRRMC Memorandum Circular No. 07, S. 2022.


**SECTION 2. SECRETARIAT.** The City Disaster Risk Reduction and Management Office shall serve as the secretariat of the Local Selection Committee and shall perform functions stated under National Disaster Risk Reduction and Management Council NDRRMC Memorandum Circular No. 07, S. 2022.

**SECTION 3. OPERATIONAL EXPENSES AND FUNDING.** All costs pertaining to the operations of the conduct of evacuation shall be chargeable against the CDRRM Fund of the City, all subject to the usual government accounting and auditing rules and regulations.

**SECTION 4. SEPARABILITY.** Should any part or provision of this order be held invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 5. EFFECTIVITY.** This order shall take effect immediately.
