



**EXECUTIVE ORDER NO. 184
Series of 2023**

**AN ORDER ESTABLISHING AN INCIDENT MANAGEMENT TEAM
FOR THE CULMINATION OF THE 2023 ARAW NG PANABO**

WHEREAS, the City of Panabo is celebrating its 22nd Araw ng Panabo on March 30, 2023, and the culmination activities are expected to draw thousands of visitors and tourists to the City;

WHEREAS, to ensure the safety and security of all participants and attendees, it is necessary to establish an Incident Management Team (IMT) to manage and coordinate emergency response efforts during the event;

WHEREAS, pursuant to the authority vested in me by law, **I, JOSE E. RELAMPAGOS**, City Mayor of Panabo, do hereby order the establishment of an IMT for the culmination of the 2023 Araw ng Panabo;

SECTION 1. COMPOSITION OF THE INCIDENT MANAGEMENT TEAM. The Incident Management Team (IMT) shall be composed of the following members:




SECTION 2. DUTIES AND RESPONSIBILITIES. The Incident Management Team (IMT) shall have the following duties and responsibilities:

1. Develop and implement an incident action plan for the event;
2. Monitor and evaluate incident response and recovery efforts;
3. Coordinate with local emergency response agencies, including law enforcement, fire, and medical services;
4. Provide public information and warnings as necessary;
5. Manage and allocate resources, including personnel, equipment, and supplies;
6. Ensure compliance with all applicable laws, regulations, and policies; and
7. Ensure the safety and security of all participants and attendees of the event.

SECTION 3. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain in force until the conclusion of activities of the 22nd Araw ng Panabo 2023.
