EXECUTIVE ORDER NO. <u>19</u>3 Series of 2023

"AN ORDER RECONSTTITUTING THE "TASK FORCE SARADO" FOR THE IMPLEMENTATION OF CLOSURE AND PADLOCKING OF BUSINESS ESTABLISHMENTS IN PANABO CITY"

WHEREAS, Local Government Units is entitled to exercise its power to create its own resources of revenues and levy taxes, fees and charges subject to the provision herein, consistent with the basic policy of local autonomy. Such taxes, fees and charges shall accrue exclusively to the local government units" (ch. 1, sec. 129, R.A. 7160);

WHEREAS, Chapter IV of City Ordinance No. 04-09, otherwise known as the Revised Revenue Code of 2009 of Panabo City, administers the permit and regulatory fees in conducting business, trade or activity in the City of Panabo;

WHEREAS, the City Government of Panabo would like to continue the strict implementation of the "no payment, no business" policy in fairness to those who diligently comply with the requirements in conducting business in the City;

WHEREAS, the Closure of Business Establishment on par. [k], sec. 152, art. 19, ch. IV of City Ordinance No. 04-09, states, "that in the event of enforcement of this Code through closure or padlocking of establishment due to non-payment of fees and failure to secure business permit, the unlicensed or delinquent business establishments shall not be spared from padlocking or closure unless an approved business permit for the current year is presented";

WHEREAS, the records of the Business Permit & Licensing Section of the Office of the City Mayor and City Economic Enterprise Management and Development Office shows that several business establishments are operating without business permit and/or without payment of market stall rental in violation of City Ordinance No. 04-09;

WHEREAS, the City Mayor through the *Task Force Sarado*, shall conduct the closure or padlocking of business establishments violating the above cited provision of the Code;

WHEREAS, Executive Order No. 35, Series of 2019 designated the composition of the Task Force Sarado for the implementation of closure and padlocking of business establishments in accordance with the Revised Revenue Code of 2009 of Panabo City;

WHEREAS, due to the new term of the City Mayor, there is a need to reconstitute the *Task* Force Sarado;

NOW THEREFORE, I, JOSE E. RELAMPAGOS, by virtue of the powers vested in me as the City Mayor of Panabo, do hereby order the following:

SECTION 1. COMPOSITION. The Task Force Sarado is hereby reconstituted and composition of which are as follows:

In case where the member cannot attend the activities of the Task Force the member shall be represented by the alternate member. The identified alternate shall be submitted to the Team Leader for her information and reference.

SECTION II. DUTIES AND RESPONSIBILITIES. The *Task Force Sarado* shall conduct the following duties and responsibilities:

- Implement closure and padlocking of business establishments operating without business permit and/or payment of market rentals; and
- Monitor any person or establishments who removes the posted "Order of Closure" without the lifting of the Order of Closure from the City Mayor.

SECTION III. REPEALING CLAUSE. All executive orders, or part or parts thereof which are inconsistent with any of the provisions of this order are hereby repealed or modified accordingly.

SECTION IV. EFFECTIVITY. This Executive Order shall take effect upon signing thereof and shall be valid until revoked or amended.
