



EXECUTIVE ORDER NO. 20
Series of 2024

**AN ORDER AMENDING THE COMPOSITION OF THE
COASTAL ENVIRONMENT PROTECTION TASK FORCE**

WHEREAS, the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, on the current social problem and environment degradation of four (4) Coastal Barangays of Panabo City, namely: Brgy. San Vicente, San Pedro, Cagangohan and J.P. Laurel, a sustainable approach in terms of coastal environment conservation and protection is deemed necessary in order to mitigate the adverse impact of climate change and for the Local Government to be more resilient towards natural disasters and calamities;

WHEREAS, a concerted effort among local and national concerned agencies is very essential in dealing with the contributory factors resulting in the destruction of mangrove forests and alteration of natural seascapes such as cutting of mangroves and illegal structures installation;

WHEREAS, there is a need to strengthen the enforcement and monitoring activities in the area by re-organizing its current composition to effectively implement the imposition of laws, intensify the campaign of mangrove protection and conservation;

WHEREAS, in view of personnel movements there is a need to amend the constitution of the Coastal Environment Protection Task Force as reconstituted under Executive Order No. 04, Series of 2024 ;

NOW THEREFORE, I, JOSE E. RELAMPAGOS, by virtue of the powers vested in me as the City Mayor of Panabo, do hereby reconstitute the Coastal Environment Protection Task Force and order the following:

SECTION 1. COMPOSITION. The composition of the Coastal Environment Protection Task Force shall be as follows:

SECTION 2. FUNCTIONS. The functions of the Coastal Protection Task Force shall be as follows:

1. Conduct regular patrolling and monitoring of the coastal areas of Panabo City;
2. Regulate entry of illegal settlers/occupants on mangrove areas and prevent/report the unauthorized construction of stalls and structures;
3. Apprehend and filing of cases to individual/s or group engaged in the cutting of mangroves and other related illegal activities;
4. Conduct community education and public awareness (CEPA) on coastal and mangrove area protection and conservation;

5. Recommend to the City Mayor or the Sanguniang Panlungsod measures to intensify the protection and conservation of coastal resources;
6. Initiate and facilitate mangrove tree planting and coastal clean-up activities;
7. Maintenance and propagation of mangrove nursery; and
8. Perform other related functions which the City Mayor may assign.


SECTION 3. MEETINGS AND QUORUM. The Task Force shall meet quarterly or as often as the exigencies of the service demand upon the call of the Team Leader or Assistant Team Leader.

The presence of the majority, fifty percent (50%) plus one (1) of its members and/or authorized representatives shall constitute a quorum and the affirmative vote of the majority of its members and/or the authorized representatives present in a meeting shall be necessary for the task force to exercise its powers and functions.

SECTION 4. REPEALING CLAUSE. All executive orders or issuances inconsistent with the provisions of this order are hereby repealed, superseded or modified accordingly.

SECTION 5. EFFECTIVITY. This order shall take effect immediately upon signing hereof.
