**EXECUTIVE ORDER NO. 203
Series of 2023**

**AN ORDER PROVIDING FOR THE TEMPORARY CLOSURE OF ROAD FROM
STO. NIÑO PARISH CHURCH – CROSSING MARYKNOLL, NATIONAL HIGHWAY TO
WHARF ROAD-CROSSING YBAÑEZ TO QUEZON STREET, BRGY. STO. NIÑO
TO PANABO FREEDOM PARK, BRGY. NEW PANDAN**

WHEREAS, Section 21 (c) of Republic Act No. 7160, otherwise known as the “*Local Government Code of 1991*”, Local Chief Executives through written order, may temporarily close both national and local roads during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications and waterworks projects or for athletic, cultural or civic activities that the local government unit concerned has sponsored, recognized or approved;

WHEREAS, *Flores de Mayo* is one of the Philippines' most anticipated festivals, culminating in a night of splendor known as the Santacruzán at the end of May to commemorate Queen Helena's search for the Holy Cross;

WHEREAS, the City of Panabo will celebrate the Santacruzán or SAGALA 2023 on May 31, 2023 and there will be a procession from Sto. Niño Parish Church, Brgy. Sto. Niño to Panabo Freedom Gym, Parks and Plaza, Brgy. New Pandan;

WHEREAS, in order to ensure the successful staging of the said event and ensure public safety and security among participants, the road that will be used in the SAGALA 2023 procession must be temporarily closed;

NOW THEREFORE, I, JOSE E. RELAMPAGOS, City Mayor, by virtue of the powers vested in me by law, do hereby order the following:


SECTION I. TEMPORARY CLOSURE OF ROAD. The herein affected road will be temporarily closed during the herein specific date and time provided, to wit:

Date and Time : May 31, 2023 (Wednesday) from 4:00 p.m. to 7:00 p.m.
Affected Road : Sto. Niño Parish Church – Crossing Maryknoll, National Highway to
(*Santacruzán course*) Wharf Road-Crossing Ybañez to Quezon Street, Brgy. Sto. Niño cor. Gaisano Mall to cor. Emergency Clinic – Panabo Freedom Park, Brgy. New Pandan

SECTION II. TRAFFIC. The Traffic Management Unit shall assist the public in the rerouting of vehicles during the temporary closure of the road.

SECTION III. EFFECTIVITY. This Executive Order shall take effect only on the specific date and time and shall last until the affected road will be reopened to traffic by appropriate authorities.
