EXECUTIVE ORDER NO. 207 Series of 2023

AN ORDER REORGANIZING THE CITY YOUTH DEVELOPMENT COUNCIL IN THE CITY OF PANABO

WHEREAS, Article 2 Section 13 of the 1987 Constitution states, "the State recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs";

WHEREAS, Section 23 of Republic Act 10742, otherwise known as the Sangguniang Kabataan (SK) Reform Act of 2015, mandates the creation of the Local Youth Development Council (LYDC) in every locality to ensure wide and multi-sectoral youth participation in local governance.

WHEREAS, pursuant to Section 24 (i), Rule III of IRR of RA 10742, the LYDC shall be composed of at least ten (10) but not more than twenty-one (21) members including the two (2) core members from the SK. The two (2) core members shall be composed of the president and the vice-president of the concerned Pederasyon and shall be supported by at least eight (8) but not more than nineteen (19) other representatives from registered youth organizations or youth serving organizations, provided that all other incumbent SK officials shall not be eligible as member of the LYDC.

WHEREAS, the LYDC shall assist in the planning and execution of projects and programs of the SK, and the Pederasyons in all levels. Education, employment, health and participation and others as identified by the LYDC shall be the advocacies of the council;

WHEREAS, the LYDC shall be composed of at least ten (10) but not more than twenty-one (21) members including the two (2) core members from the SK. The two (2) core members shall be composed of the president and the vice-president of the concerned Pederasyon and shall be supported by at least eight (8) but not more than nineteen (19) other representatives from registered youth organizations or youth-serving organizations, provided that all other incumbent SK officials shall not be eligible as a member of the LYDC.

WHEREAS, the Department of the Interior and Local Government (DILG) had issued Memorandum Circular (MC) No. 2018-124 and MC No. 2019-151 reiterated the creation of the Local Youth Development Council and the Guidelines on Local Youth Development Planning, Comprehensive Barangay Youth Development Planning, and Annual Barangay Youth Investment Programming of the National Youth Commission;

WHEREAS, it is the duty of the City through the LYDC to reach out to the youth and to encourage them to actively participate and be involved in the programs of the Sangguniang Kabataan;

WHEREAS, in view of the inclusion of the newly accredited youth organizations in the National Youth Commission (NYC) there is a need to reorganize the LYDC in the City of Panabo as constituted under Executive Order No. 21, Series of 2020;

NOW THEREFORE, I, **JOSE E. RELAMPAGOS**, City Mayor of Panabo, Province of Davao del Norte, by virtue of the powers vested in me, do hereby order:

SECTION 1. REORGANIZATION. The City Youth Development Council (CYDC) of Panabo City is hereby reorganized as follows:
