



**EXECUTIVE ORDER NO. 21  
SERIES OF 2024**

**AN ORDER AMENDING THE COMPOSITION OF THE PANABO CITY  
MARICULTURE PARK TECHNICAL WORKING GROUP**

**WHEREAS**, Article XII, Section 2 of the Constitution provides that the State shall protect the nation's marine wealth and exclusive economic zone and reserve its use and enjoyment exclusively to Filipino citizen;

**WHEREAS**, the Panabo City Mariculture Park (PCMP) has become a tourist attraction of this City and at the same time an economic zone for the past years since its establishment;

**WHEREAS**, City Ordinance No. 14, Series 2012, provided the comprehensive development of the Panabo City Mariculture Park, covering the area of 617.00 hectares of the Barangays San Pedro, Cagangohan and JP Laurel;

**WHEREAS**, Section 7 of CO 14-12, provided the composition of PCMP – Technical Working Group to assist the Executive Management Council in its supervision and operation of the Mariculture Development Park;

**WHEREAS**, in view of personnel movements, there is a need to amend the composition of the Mariculture Park Technical Working Group as constituted under Executive Order No. 43, Series of 2021;

**NOW THEREFORE, I, JOSE E. RELAMPAGOS**, by virtue of the power vested in me as the City Mayor of Panabo, do hereby order the following:

**SECTION 1. PANABO CITY MARICULTURE PARK - TECHNICAL WORKING GROUP (TWG).** The composition of the Panabo City Mariculture Park – Technical Working Group is hereby amended as follows:

**SECTION 2. FUNCTIONS OF THE PCMP TECHNICAL WORKING GROUP.** The TWG shall perform the following functions:

1. Evaluate applications for permit to operate and gratuitous permits of applicants at the Mariculture Development Park based on the guidelines and requirements set in this Ordinance;
2. Recommend measures and policies for the sustainability of the Mariculture Development Park, protection of the rights of small and marginal fisherfolks in the preferential use of areas for Mariculture development and maintenance of sound ecological balance and protection and enhancement of fishery and coastal resources within the Mariculture Park for the consideration of the EMC;
3. Monitor compliance of Environmental Compliance Certificate for the Mariculture Park projects;
4. Provide technical advice on the status of coastal and marine fishery resources;
5. Develop new methods of assessing the impact of the Mariculture Park and address biological, economic and social concerns;
6. Develop financing and marketing strategies to attract investors, and generate livelihood opportunities for the marginalized sector;
7. Recommend to the EMC short-term and long-term plans, and infrastructure support for the Mariculture Development Park;
8. Recommend seminars, conferences, trainings and fora;
9. Assess the socio-economic impact of project of the Mariculture Development Park;

10. Formulate/recommend measures to enhance law enforcement for the protection of investments and conservation of fishery and coastal resources in the Mariculture Park;
11. Formulate a manual of operations for PCMP, and
12. Other functions as may be delegated by the EMC.

**SECTION 3. SECRETARIAT.** The City Agriculturist Office, through the Mariculture Park Section/Fisheries Section shall serve as the Secretariat of the TWG and shall perform the following:


1. Shall keep necessary documents and records of all meetings and other activities of the TWG;
2. Perform such other functions as may be assigned by the TWG.

**SECTION 4. MEETINGS AND QUORUM.** The TWG shall meet as often as necessary upon the call of the Chairperson and presides over meetings. In the case that a member is unable to attend a meeting, the authorized representative will be the officer with the next highest rank.

The presence of at least a majority of its members and/or the authorized representatives shall constitute a quorum and the affirmative vote of the majority of its members and/or the authorized representatives present in a meeting shall be necessary for the committee to exercise its powers and functions.

**EFFECTIVITY.** This order shall take effect immediately upon signing hereof.
