



**EXECUTIVE ORDER NO. 212  
Series of 2023**

**AN ORDER TEMPORARILY CLOSING PORTIONS OF THE ROAD  
FRONTING THE FREEDOM PARK, DAANG MAHARLIKA HIGHWAY TO  
CORNER QUIRINO ST. AND QUEZON ST. TO ROXAS ST., BRGY. NEW PANDAN**

**WHEREAS**, Section 21 (c) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", Local Chief Executives through written order, may temporarily close both national and local roads during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications and waterworks projects or for athletic, cultural or civic activities that the local government unit concerned has sponsored, recognized or approved;

**WHEREAS**, the City of Panabo will take part in the celebration of the 2023 Pride Month or the SAGAYLA 2023 this coming June 26, 2023, through a procession from the Freedom Park, National Highway to Panabo Freedom Gym, Parks and Plaza, Brgy. New Pandan;

**WHEREAS**, a section of the roads used for the SAGAYLA 2023 procession will be temporarily closed in order to ensure the successful staging of the aforementioned event;

**NOW THEREFORE, I, JOSE E. RELAMPAGOS**, City Mayor, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION I. TEMPORARY CLOSURE OF ROAD.** A portion or Northbound Lane of the Daang Maharlika National Highway fronting the Freedom Park to Cor. Quirino St. (Landbank) – Quezon St. (Pag-Asa Pawnshop) to Roxas St. (Emergency Clinic) – Freedom Gym, Brgy. New Pandan will be temporarily closed, specifically during the herein-specific time provided, viz:


Date and Time : **June 26, 2023 (Monday) from 4:30 p.m. to 6:00 p.m.**

**SECTION II. ALTERNATE ROUTE.** The Southbound (going towards Davao City) Lane of the Daang Maharlika Highway will be accessible for a two-way traffic;

**SECTION III. TRAFFIC.** The Traffic Management Unit shall assist the public in the rerouting of vehicles during the temporary closure of the road.

**SECTION IV. EFFECTIVITY.** This Executive Order shall take effect only on June 26, 2023 until the affected road will be reopened to traffic by appropriate authorities.
