## EXECUTIVE ORDER NO. 217 Series of 2023

## AN ORDER DESIGNATING AN ALTERNATE MEMBER OF THE BIDS AND AWARDS COMMITTEE OF THE CITY GOVERNMENT OF PANABO

WHEREAS, it is the policy of the state to promote good governance and adhere to the principles of transparency, accountability, equity, efficiency, and economy in its procurement process;

WHEREAS, Republic Act No. 9184, entitled "An Act Providing for the Modernization, Standardization and Regulation of the Procurement Activities of the Government and for Other Purposes" and the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 was promulgated for the purpose of prescribing the necessary rules and regulations for the modernization, standardization, and regulation of the procurement activities of the Government of the Philippines;

WHEREAS, Republic Act 9184, otherwise known as the "Government Procurement Reform Act" requires the procuring entity to establish in its head office a single Bids and Awards Committee (BAC), to undertake functions specified in Section 12 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, under Section 11.2.4. of 2016 Revised IRR of R.A. 9184, the Head of Procuring Entity may designate an alternate BAC member/s, who shall have the same qualifications as that of the members originally designated under Section 11.2.2 of the same IRR;

NOW THEREFORE, I, JOSE E. RELAMPAGOS, by virtue of the powers vested in me as the City Mayor of Panabo, do hereby order to designate MR. JOVEN M. SEPE, City Budget Officer as an Alternate Member of the Bids and Awards Committee.

SECTION I. ALTERNATIVE MEMBER. To constitute a quorum, the Alternate Member shall be called to attend BAC meetings and/or other procurement activities in place of the regular member who is absent.

The alternate member shall receive the proportionate honoraria whenever the original member or members are absent. The term of the alternate member shall be the same as that of the regular member.

SECTION II. FUNCTIONS. The duties and functions of the BAC shall be in accordance with Section 12 of the 2016 Revised IRR of R.A. 9184 and other pertinent provisions thereof and must always adhere to the "Jury Duty" concept of procurement-related assignments, as stated in Section 38 of the 2016 Revised IRR, in order to complete the entire procurement process at the earliest possible time without unnecessary delay.

SECTION III. DISSEMINATION. The Bids and Awards Committee and the concerned official shall receive a copy of this order.

SECTION IV. SEPARABILITY. Should any part or provision of this order be held invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SECTION V. EFFECTIVITY. This order shall take effect upon signing hereof.
