EXECUTIVE ORDER NO. 225 Series of 2023

AN ORDER ENJOINING ALL SANGGUNIANG KABATAAN CITY FEDERATION, LOCAL YOUTH DEVELOPMENT COUNCIL AND ALL PANABO CITY YOUTH ORGANIZATIONS TO SUPPORT AND COOPERATE IN THE UPCOMING CELEBRATION OF THE PANABO CITY YOUTH FESTIVAL ON AUGUST 27, 2023 TO SEPTEMBER 1, 2023

WHEREAS, Article 2 Section 13 of the 1987 Constitution states that "the State recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs";

WHEREAS, Republic Act No. 8044 otherwise known as the Youth in Nation-Building Act creates the structure to implement a comprehensive and coordinated program for the youth and gives recognition to the youth's responsibility in fulfilling their vital role in nation-building;

WHEREAS, Section 30 of Republic Act No. 10742 or the Sangguniang Kabataan Reform Act of 2015, mandates the observance of Linggo ng Kabataan in every barangay. municipality, city and province on the week where the 12th of August falls;

WHEREAS, Chapter VI, Section 33 (a) of RA 10742, mandates the conduct of an annual activity for the youth to be known as the Linggo ng Kabataan every 12th of August. coinciding with the observance of the International Youth Day.;

WHEREAS, the City Government of Panabo through the 9th City Council, promulgated City Ordinance No. 3-2023 entitled Declaring Every 2nd Week of August of Each Year as the Panabo City Youth Festival Also Known as the Linggo ng Kabataan Celebration and Providing Funds Thereof;

WHEREAS, due to budgetary difficulties, the Panabo City Youth Festival or the Linggo ng Kabataan in Panabo City will be moved from the 2nd week of August to August 27, 2023-September 1, 2023;

WHEREAS, pursuant to Section 455 (b)(1)(xvi) and (b)(2)(iii) of the Local Government Code of 1991 grants the Local Chief Executive (LCE) the power to exercise general supervision and control over all programs, projects, services and activities of the City. The LCE may issue such necessary Executive Orders for the faithful and appropriate execution of laws and ordinances;

NOW, THEREFORE, I, JOSE E. RELAMPAGOS, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. YOUTH FESTIVAL. The Panabo City Youth will be celebrated on August 27, 2023 to September 1, 2023 with the theme: "Green Skills for Youth: Towards a Sustainable World".

SECTION 2. PARTICIPATION. The City Government of Panabo enjoins all officers and members of the Sangguniang Kabataan (SK) City Federation, Local Youth Development Council, and Panabo City Youth Organizations to provide their full and active support and their utmost cooperation in all activities relative to the 2023 Panabo City Youth Festival.

SECTION 3. DISSEMINATION. The Local Youth Development Office in cooperation with the SK City Federation Office and City Information Office shall cause the widest dissemination of this order.

SECTION 4. EFFECTIVITY. This order shall take effect immediately after signing hereof.
