## EXECUTIVE ORDER NO. 232 SERIES OF 2023

# AN ORDER RENAMING THE PANABO CITY INFIRMARY OVERSIGHT COMMITTEE TO PANABO CITY HOSPITAL OVERSIGHT COMMITTEE AND TO AMEND ITS MEMBERSHIP STRUCTURE

**WHEREAS**, Article II, Section 15 of the Philippine Constitution provides that the State shall protect the right to health of the people and instill health consciousness among them;

WHEREAS, it is the policy of the state to ensure that all communities have access to health centers and other facilities necessary to carry out health services;

WHEREAS, under Republic Act No. 7160 otherwise known as the Local Government Code of 1991, local government units shall exercise such powers and discharge such functions and responsibilities as are necessary, appropriate or incidental to the efficient and effective provision of basic services and facilities which cover, among others, health services including secondary and tertiary hospitals;

**WHEREAS**, the City of Panabo has acquired a parcel of land for the purpose of establishing the Panabo City Hospital;

**WHEREAS**, the hospital will provide cost-effective and readily available healthcare services, it intends to serve the healthcare requirements of Panabo residents and those residing in neighboring municipalities and cities during medical emergencies;

WHEREAS, Executive Order No. 26, Series of 2021, established the Panabo City Infirmary Oversight Committee and tasked it with formulating policies and procedures for the administration and operation of the Panabo City Infirmary;

**NOW THEREFORE, I, JOSE E. RELAMPAGOS**, City Mayor, by virtue of the powers vested in me by law, do hereby rename the Panabo City Infirmary Oversight Committee to Panabo City Hospital Oversight Committee and further order the following:

**SECTION 1. COMPOSITION.** The Panabo City Hospital Oversight Committee and its Technical Working Group shall be amended as follows:

**SECTION 2. FUNCTIONS**. The OC and TWG shall perform the following functions:

## The Oversight Committee shall:

1. Coordinate with the Department of Health, Provincial Government of Davao del Norte in the preparation of relevant documents for licensing and operation of the Panabo City Infirmary;

- 2. Present the final draft ordinance for the operation and administration of the Panabo City Hospital to the Sangguniang Panlungsod.
- 3. Formulate the operations manual of the Panabo City Hospital.

#### The TWG shall:

- Come up with the draft of the ordinance for the operation and administration of the Panabo City Infirmary and provide thereof the policies and guidelines, standard operating procedure and/or manual for its operation.
- 2. Perform such other duties as may be assigned by the OC.

The **Secretariat** shall assist the OC and TWG in its functions and shall keep necessary documents and records of all meetings and activities of the OC and TWG.

**SECTION 3. REPEALING CLAUSE.** All orders and directives inconsistent with any provision found herein are hereby repealed, superseded, or modified accordingly.

SECTION 4. EFFECTIVITY. This order shall take effect immediately upon signing hereof.
