EXECUTIVE ORDER NO. 280 Series of 2023

AN ORDER PROVIDING A ONE-WAY TRAFFIC SCHEME AND TEMPORARY RE-ROUTING OF VEHICULAR TRAFFIC DURING ALL SAINTS DAY AND ALL SOULS DAY AT THE OLD PUBLIC CEMETERY ON NOVEMBER 1-2, 2023

WHEREAS, the observance of All Saints' Day and All Souls' Day shall be on November 1-2, 2023 and it has been a long-held practice among Filipinos to pay homage to their deceased relatives by visiting graves and memorial parks during the Undas Season;

WHEREAS, it is the responsibility of the city government to ensure that traffic flow remains efficient, organized, and accessible to the general public on all thoroughfares leading to private and public cemeteries during the said period;

WHEREAS, a request made by the head of the Panabo City Traffic Management Unit, to establish a one-way traffic and rerouting scheme to address the issue of traffic congestion caused by the significant influx of individuals expected to visit the old public cemetery during the Undas Season;

WHEREAS, there is a need to implement a temporary traffic diversion on all thoroughfares that provide access to the old public cemetery at Brgys. Gredu and New Visayas;

WHEREAS, under the General Welfare Clause of the Local Government Code (Section 16 of R.A. 7160), expressly provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

NOW THEREFORE, I, JOSE E. RELAMPAGOS, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. SUBJECT ROAD. The subject road for one-way zones shall cover the following:

(ENTRANCE) From Quirino St. junction UM/Polymedic up to the intersection of New Visayas Elementary School going to Diversion Road (Monica Homes Subd. To Paramedical HS) up to Cabaluna St. going to junction of Daang Maharlika Highway (EMCOR) Brgy. Gredu (EXIT)

Attached is the route map for reference.

SECTION 2. ENTRY TO OLD PUBLIC CEMETERY. The entrance leading to the old public cemetery shall be free from vehicular traffic, thus, all vehicles are prohibited from entering the cemetery.

Entrance:

Brgy Gredu, Cabaluna St. (intersection Manolette Bakeshop) and Brgy. New Visayas, Quirino St. (intersection Magnanao

SECTION 3. COVERED PERIOD. The implementation of the one-way traffic and rerouting scheme will take effect on November 1, 2023 to November 2, 2023 from 6:00 a.m to 7:00 p.m.

SECTION 4. WARNING SIGNS. The Traffic Management Unit shall provide the traffic advisory/rerouting signs and assist the public and concerned vehicles during the period.

SECTION 5. IMMEDIATE DISSEMINATION. The City Information Office is hereby directed to disseminate this order. The office of the City Administrator is requested to monitor compliance with the directive.

SECTION 6. EFFECTIVITY. This order shall take effect only on the aforesaid period.
