### EXECUTIVE ORDER NO. 199 SERIES OF 2023

# AN ORDER MANDATING THE 24/7 OPERATIONS OF THE PANABO CITY CDRRMO OPERATIONS CENTER

**WHEREAS**, Republic Act No. 10121 also known as the "*Philippine Disaster Risk Reduction and Management Act of 2010*", mandated the establishment of an operating facility that shall be operated on a twenty-four (24) hour basis;

**WHEREAS**, the City of Panabo recognizes the need for an effective and efficient disaster risk reduction and management system to ensure the safety and well-being of its residents and communities;

**WHEREAS**, the Panabo City Disaster Risk Reduction and Management Office (CDRRMO) plays a pivotal role in disaster preparedness, response, and recovery efforts;

**WHEREAS**, it is crucial to ensure that the CDRRMO Operations Center is readily available at all times to respond to emergencies and manage disaster situations in the City of Panabo;

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991, authorizes each local government unit to have the autonomy to establish localized provisions anchored from national laws and rules;

**NOW, THEREFORE, I, JOSE E. RELAMPAGOS**, City Mayor of Panabo City, in accordance with the powers vested in me by the laws and regulations governing the City of Panabo, do hereby order the following:

# SECTION 1. ESTABLISHMENT OF THE 24/7 OPERATIONS OF THE CDRRMO OPERATIONS CENTER.

The City Government of Panabo through the CDRRMO Operations Center hereby establishes 24/7 [24 hours a day, 7 days a week] operations to ensure continuous and effective monitoring, coordination, and response to disaster and emergency situations within the city.

#### Location.

The CDRRMO Operations Center shall be located at the New City Hall Compound, Brgy. JP Laurel, Panabo City,

#### Alternate Location.

In case of damage or event which may render the facility inoperable, the alternate site shall be the Panabo Multi-Purpose Cultural and Sports Complex Second Level.

#### SECTION 2. STAFFING AND DEPLOYMENT.

1. The CDRRMO Operations Center shall maintain an adequate number of trained and competent personnel to operate on a rotating shift basis, ensuring that there are sufficient staff members at all times to handle emergencies

- 2. The CDRRMO shall establish a clear schedule for shifts, ensuring that staff members receive adequate rest breaks and that the center is continuously staffed.
- 3. The CDRRMO Operations Center shall coordinate with relevant agencies, to ensure timely response and support during emergencies.

### SECTION 3. EQUIPMENT AND RESOURCES.

- 1. The CDRRMO Operations Center shall maintain and regularly update the necessary equipment, technology, and communication systems to effectively manage disaster situations and coordinate with response teams.
- 2. Adequate resources, such as emergency vehicles and supplies, shall be made available to the CDRRMO Operations Center to ensure its operational readiness.

#### SECTION 4. TRAINING AND CAPACITY BUILDING.

- 1. The CDRRMO shall conduct regular training, drills, and capacity-building programs for its staff to ensure they are well-prepared for various emergency scenarios.
- 2. The CDRRMO Operations Center shall collaborate with local and national agencies to enhance its expertise and knowledge in disaster risk reduction and management.

#### SECTION 5. REPORTING.

The CDRRMO Operations Center shall provide regular reports and updates to the City Government and the Mayor's Office on its operations, response activities, and any significant developments related to disaster and emergency situations.

**SECTION 6. EFFECTIVITY.** This order shall take effect immediately upon approval.
