



EXECUTIVE ORDER NO. 308

**AN ORDER PROVIDING FOR THE TEMPORARY CLOSURE OF ROADS AND
REROUTING OF VEHICLES DURING THE PASKUHAN SA PANABO 2023**

WHEREAS, Section 21 (c) of Republic Act No. 7160, otherwise known as the "*Local Government Code of 1991*," authorizes the local chief executive to temporarily close both national and local roads for athletic, cultural, or civic activities that the local government unit concerned has sponsored, recognized or approved;

WHEREAS, the City of Panabo will organize a series of activities and events from December 15-21, 2023, as a gesture of gratitude for the blessings received in 2023 and to kickstart the Christmas season with ***Paskohan sa Panabo 2023***;

WHEREAS, to ensure public safety and security of the public and to lighten the traffic during the said activities, it is necessary to implement temporary road closures and reroute affected vehicles;

NOW, THEREFORE, I, JOSE E. RELAMPAGOS, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. TEMPORARY CLOSURE OF ROADS AND REROUTING OF VEHICLES.
Temporary road closures and vehicle rerouting are required to alleviate congestion during the following activities of the City:



SECTION 2. WARNING SIGNS. The TMU shall provide the traffic advisory/rerouting signs as well to assist the public and concerned vehicles during the said period.

SECTION 3. EFFECTIVITY. This order shall take effect on the abovementioned dates and time until such [affected] road will be reopened to traffic by appropriate authorities.
