AN ORDER REORGANIZING THE TASK FORCE BANWAG OF PANABO CITY

WHEREAS, the City of Panabo recognizes the need to improve the quality of life of every Panaboans through adequate and sustainable energy services through electrification of all barangays;

WHEREAS, the City ensures the implementation of Rural and Urban Electrification (RUE) projects to strengthen the peace and order, public safety and development in Panabo City;

WHEREAS, a Task Force Banwag, "*Banwag*" is a Cebuano term which means to "*illuminate a place*", shall be created to assist in the implementation of the RUE projects to isolated and disadvantaged areas in the City of Panabo and to perform other related activities that will improve electrification services;

WHEREAS, as established by Executive Order No. 14, Series of 2019, the Task Force *Banwag* needs to be reorganized to update its composition;

NOW THEREFORE, I, JOSE E. RELAMPAGOS, City Mayor, by virtue of the powers vested in me by law, do hereby order the following:

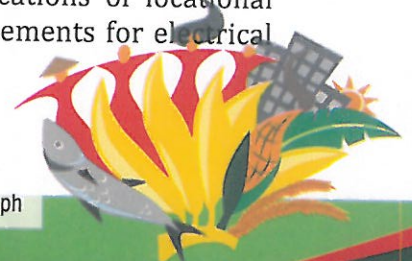
SECTION I. COMPOSITION. The Task Force Banwag is hereby reorganized as follows:

SECTION II. DUTIES AND FUNCTIONS. The Task Force (TF) Banwag shall perform the following functions:

Task Force

- Conduct a citywide seminars/information drive on the proper usage of electricity and its devices and capability building;
- Coordinate the program with barangay officials;
- Extend technical assistance to constituents for their applications of locational clearances, building, fire, electrical permits and other requirements for electrical installation;



- d. Create a Support Staff to support the TF in its logistic activity and to conduct citywide street light monitoring including nighttime; and
- e. Assess puroks/barangays on the unavailability of electricity.

Program Coordinator

- a. Complement the TF Banwag in its duties and functions; and
- b. Facilitate the liaison between the Local Chief Executive, Task Force, secretariat and barangays concerned ensuring coordination, dealing and response to electrification concerns.

SECTION III. FUNDING. All costs pertaining to the operations and activities of the TF Banwag shall be taken from the City Mayor's Office, Kuryente Watch Program, all subject to the usual government accounting procedures and auditing regulations

SECTION IV. EFFECTIVITY. This order shall take effect immediately.
