EXECUTIVE ORDER NO. 35 Series of 2024

AN ORDER AMENDING EXECUTIVE ORDER NO. 153, SERIES OF 2023 DELEGATING HON. MARK EDUARD B. PEÑAS, AS THE NEW REPRESENTATIVE OF THE ASSOCIATION OF BARANGAY CAPTAINS (ABC) TO THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF PANABO CITY AND ALSO DELEGATING NOVIEN RESPECIO AS PLEB SECRETARIAT

WHEREAS, the Local Chief Executive issued Executive Order No. 153, Series of 2023 last January 11, 2023 entitled, "An Order Reconstituting the Panabo City People's Law Enforcement Board (PLEB)" in accordance with Republic Act No. 6975 or the Department of the Interior and Local Government Act of 1990 as amended by Republic Act No. 8551 otherwise known as the Philippine National Police Reform and Reorganization Act of 1998;

WHEREAS, under Executive Order No. 153, Series of 2023, the following were the respective representatives and members of PLEB:

WHEREAS, in the Barangay and Sangguniang Kabataan Elections held last October 30, 2023, the representative of ABC, Hon. Reynaldo P. Ginsola was not re-elected thereby causing vacancy in the composition of the People's Law Enforcement Board (PLEB);

WHEREAS, in order to fill the vacancy, ABC issued Resolution No. 1, Series of 2024 entitled "A Resolution Delegating Hon. Mark Eduard B. Peñas, Barangay Captain of Barangay New Visayas to be Representative of the Liga ng mga Barangay sa Pilipinas-Panabo City Chapter to the People's Law Enforcement Board (PLEB) of this City";

WHEREAS, Section 68 of Republic Act No. 8551 provides that, "The term of office of the members of the PLEB shall be for a period of three (3) years from assumption of office. Such member shall hold office until his successor shall have been chosen and qualified."

NOW THEREFORE, I, JOSE E. RELAMPAGOS, City Mayor, by virtue of the powers vested in me by law, do hereby reconstitute the People's Law Enforcement Board of Panabo City and further order the following:

SECTION 1. COMPOSITION. The composition of the members of the PLEB shall be as follows:

The members shall elect from among themselves the Chairperson of the Board.

SECTION 2. POWERS AND FUNCTIONS. The PLEB empowers the people against abusive and erring policemen. It has the power to hear and adjudicate all citizen's complaints formally filed with, or referred to it, against any uniformed members of the PNP, and. If warranted, impose the corresponding penalty.

The functions and roles of the PLEB are provided under a) Republic Act No. 6975, otherwise known as the Department of the Interior and Local Government Act of 1990, b) Memorandum Circular No. 91-002 of the National Police Commission, c) Republic Act No. 8551, otherwise known as the Philippine National Police Reform and Reorganization Act of 1998, d) Department of Interior and Local Government (DILG) Memorandum Circular No. 2002-010 or the "Revised Rules of Procedure in the Hearing and Adjudication of Citizens Complaints Against Uniformed Members of the Philippine National Police before the PLEB", and e) Other applicable laws, rules, regulations and issuances.

SECTION 3. SECRETARIAT. Ms. **NOVIEN RESPECIO** from the Office of the City Mayor is hereby designated as PLEB Secretariat. The secretariat shall provide administrative support such as keeping the minutes, drafting of official correspondences, logistics affairs and other relevant tasks as may be assigned by the Board.

SECTION 4. TERM OF OFFICE. The term of office of the members of the PLEB shall be for a period of three (3) years from the assumption of office unless sooner removed for cause or some other valid grounds and shall hold office until his/her successor shall have been chosen and qualified.

Further, Hon. Mark Eduard B. Peñas being a successor, shall serve only the unexpired term of Hon. Reynaldo P. Ginsola.

SECTION 5. TECHNICAL ASSISTANCE. The DILG Panabo City shall provide technical and administrative assistance to the PLEB and its Secretariat.

SECTION 6. EFFECTIVITY. This order shall take effect immediately upon signing hereof.
