EXECUTIVE ORDER NO. 37 Series of 2024

AN ORDER ESTABLISHING THE OPERATIONS OF FOOD STALLS IN PROMOTION OF THE PANABO CITY MARKET COMPLEX

WHEREAS, as enshrined in Article XIII, Section 2 of the Philippine Constitution, it is the policy of the state to promote social justice which includes the commitment to create economic opportunities based on freedom of initiative and self-reliance;

WHEREAS, to promote the establishment of the Panabo City Market Complex (MarCom) and foster season of festivity and goodwill the City through the City Mayor's Office tapped the organized pop-up stalls in Panabo City to put up food stalls during the blessing of the MarCom;

WHEREAS, the food stalls shall showcase, trade and sell and market their food products during the Blessing Ceremony of the Panabo City Market Complex with the theme *Hello Summer Food Festival* from April 24, 2024, to May 7, 2024;

WHEREAS, the operation of the pop-up stalls or food stalls shall be in accordance and comply with the sanitation standards and permit to operate;

WHEREAS, Section 16 of Republic Act 7160, the General Welfare Clause of the Local Government Code expressly mandates the local government units to enhance economic prosperity and social justice, promote full employment among their residents;

NOW THEREFORE, I, JOSE E. RELAMPAGOS, City Mayor of the City of Panabo, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. SETTING UP OF STALLS. The food stalls shall be set up and shall use the MarCom grounds as the location of the food park from April 24, 2024, to May 7, 2024.

SECTION 2. PERMIT, LICENSES AND FEES. The food stalls shall comply and secure the necessary permit(s) and pay the corresponding fees as required under City Ordinance No. 04-09 otherwise known as the Revised Revenue Code of 2009 of the City of Panabo.

SECTION 3. MAINTENANCE AND OPERATION. The food stalls shall be maintained and under the supervision of the City Mayor's Office and shall carry out the following responsibilities:

- 1. The City shall approve the food stalls that will participate in the food park.
- 2. The City shall undertake periodic inspections of the food park during its operation.
- 3. All food stalls shall comply with all the necessary permit and/or licenses before its operation.
- 4. The food stall personnel shall adhere to appropriate personal hygiene and sanitation practices when preparing food.
- 5. The food stalls shall be responsible for the cleanliness of the food park and the disposal of wastes in the designated garbage dump area.

SECTION 4. SEPARABILITY CLAUSE. If any portion or provision of this order will be declared inconsistent or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately upon signing hereof.
